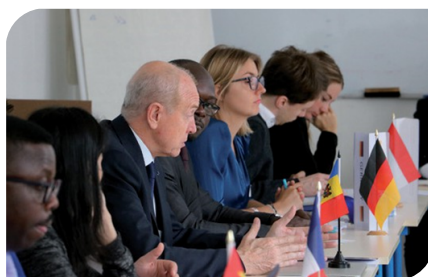

Under what status can IRIS Sup' students be hired?

Apprenticeship contract, internship, civic service, fixed-term contract, permanent contract, International Volunteer in Business (VIE), International Volunteer in Administration (VIA), International Solidarity Volunteer (VSI), etc.



Do IRIS Sup' interns need to be paid?

In accordance with French law, compensation is mandatory if the internship lasts more than 44 days. If you are not subject to French law, compensation is not mandatory, but we do encourage it.



Is an internship agreement required?

In France, an internship agreement is mandatory and must be signed by three parties: IRIS Sup', the student, and the host organisation.
